Financial Report: John Weier presented the June and July 2019 financial reports. Everything is on track as expected.

Marketing Report: Nancy Gardner discussed marketing initiatives related to summer enrollment, which includes group presentations, media, FB, billboard, events, and mailer information.

Enrollment/Retention Report: Deanna Keller discussed the present student numbers, trend, and the retention goal of 70% and the enrollment goal of 220. There are currently 206 students enrolled in ESLA.

School-wide Goals Report: Nancy Gardner discussed what the school-wide goals will look this coming school year. The report to the board will include a goal or two to be addressed depending on data that is available.

Academic/Intervention Plan: Deanna Keller discussed 2018-19 NWEA data and intervention initiatives for the new school year. The intervention team from last school year is also in place for this school year.

Building and Grounds Report: Nancy Gardner reported on what has been accomplished during the summer, what is in the works, and what is needed in the near future. The major projects completed include; hallway and classroom tile in the north wing, cafeteria repainted, PA system updated and wood chips for the playground.

NMU Representative Report: Neil Hartman discussed the administrator workshop August 19 and 20, 2019 that will focus on Math.

Charter Contract: The reauthorization process is complete and ESLA is chartered by NMU for another five years.

NMU Performance Framework: The Performance Framework was presented in its entirety. The document addresses all goal areas that NMU will be monitoring this coming school year.

Panorama School Climate Survey: This is an online tool that parents, students and staff will be using to assess school climate. Data will be used to address improvement.

East Shore Leadership By-Laws: The new proposed By-Laws were distributed to board members to review before next month's meeting. Adopting the new By-Laws is a recommendation from NMU as a result of the reauthorization process, therefore they would replace the previous By-Laws.

NMU Monitoring Report: NMU sends a monitoring team to ESLA on an annual basis to evaluate how the school is progressing. The report is a comprehensive summary from NMU's site visit this past school year. Covers all areas accurately.

Emergency Operations Plan: EOP's must be presented every two years to the board of directors for approval. The present document was distributed to board members for review before the next board meeting. There are new guidelines from the State as to what the plan should encompass.

Policy and Procedure Updates: Policy and Procedure draft was distributed to the board to review before next month's meeting. A summary sheet of policy highlights was also presented.
